Work Inclusions

1) Raise Flooring Scope of Work:

1 Site Survey & Measurement

- Conduct a site visit for accurate area measurement.
- Assess floor levelling and verify load distribution requirements.

2. Supply of Raised Flooring System

- Raised floor panels with minimum 800 kg/m² load-bearing capacity, depending on 2equipment layout.
- Panels shall be anti-static, fire-retardant, and finished with high-pressure laminate (HPL) or conductive vinyl top layer.
- Modular and removable tile design for access to underfloor systems.

3. under structure Framework

- Supply and install adjustable pedestals and stringers to achieve a minimum floor height of [specify height, e.g., 100mm or 150mm as per site requirement].
- Corrosion-resistant under structure system for long-term performance.

4. Installation

- Precise levelling and alignment of panels.
- Secure fixing of pedestals to the subfloor with approved adhesives/anchors.
- All necessary edge trimming and panel cut-outs for cable ingress, airflow grills, and grounding.

5. Earthing & Bonding

• Connect raised floor system to Data Centre's grounding network as per electrical safety standards.

6. Cut-outs and Accessories

- Provide openings for cable trays, HVAC floor grills, and grommets as per approved layout.
