- Bidder needs to quote composite rate i.e. CGST + SGST + CESS or CGST + IGST + CESS as the case may be. Any changes in Govt. Taxes / Duties would be applicable as on actual at the time of invoice processing.
- 2. Necessary statutory deductions, in accordance with rules as applicable, may be deducted at source by GIPL from the above quoted amount.
- 3. The quoted rate is inclusive of all lodging, boarding, travelling charges as may be required during the tenure of execution of the project.
- 4. Liquidated damages

The bidder acknowledges that time is the essence of the Contract and in case of any delay in completion of the project; the said delay shall cause substantial damage to GIPL/ its client.
