5. Bidder should have Sales/service office in Gujarat (Preferably in Ahmedabad / Gandhinagar) operational for more than 03 years as on tender floating date.
6. Copies of any of the:- Property Tax Bill / Electricity Bills / Telephone Bill / Valid Lease Agreement should be submitted with the bid confirming the time period of more than 3 years as on tender floating date and to be submit by eligible bidders.

Period of CAMC of W-Fi Equipment Contract period: - for 1 year.

Scope of Work:

- Bidder shall provide 24x7 remote support on call basis and arrange for on-site visit by engineer for issues that cannot be resolved remotely.
- Bidder shall carry out quarterly on-site preventive maintenance of all equipment listed above and submit formal report of the same with authorized end user.
- GIPL may terminate the contract on advance notice of 30 days without providing any clarification thereto.
- All work within SPIPA premises shall be carried out as per SPIPA safety norms. Bidder shall ensure adequate safety measures and Personal Protective Equipment for its personnel working in SPIPA premises.
- Bidder shall have to provide support on 24x7x365 basis and should define the escalation matrix.

Payment Terms: -

- The payment shall be made as certified by GIPL representative on submission of PM (Preventive Maintenance) reports, duly signed by GIPL Representative at SPIPA.
- Payment shall be made by GIPL at the end of every quarter along with reports.

Terms & Conditions

1. Bidder needs to quote composite rate i.e. CGST + SGST + CESS or IGST + CESS as the case may be. Any changes in Govt. Taxes / Duties would be applicable as on actual at the time of invoice processing.
2. Necessary statutory deductions, in accordance with rules as applicable, may be deducted at source by GIPL from the above quoted amount.
3. The quoted rate shall be inclusive of all lodging, boarding, travelling charges as may be required during the tenure of execution of the contract.
4. GIPL reserves the right to cancel this requirement without assigning any reason.
5. The final decision however, on selection of the Service provider will be at discretion of the competent authority of GIPL.
6. The Service provider should incur all the expenditure towards provisioning of these Comprehensive AMC services for GIPL.
7. Evaluation of quotation shall be based on the Total Cost to the Company. The quotation that complies with all of the requirements and offers the lowest price shall be selected. Any offer that does not meet the requirements shall be rejected.

The Service Provider agrees and undertakes that its Personnel engaged in providing the Services shall at all times remain its employees and shall at no time make any claim of employment (or otherwise) against the Company.
